

In memory of James and Julie Avery

This Foundation was established to honor the memories of siblings James and Julie Avery. James was born on April 4, 1956 to Harvey and Mary Avery of Dubuque. In January 2014, he was diagnosed with stage 4 colon cancer. The cancer had already spread to his rectum, liver and bones at the time of his diagnosis. Jim battled the disease with great courage and determination until he passed away on December 5, 2015. Julie was born on June 9, 1961 to Harvey and Mary Avery. She was diagnosed with fibrosis sarcoma in June of 1981 and treatment required the amputation of one of her legs. She battled the cancer with grace and concern for her family until August 27, 1982 when she passed away peacefully. The Foundation honors their memories by helping other cancer patients in need.

How we can help!

The Avery Foundation will provide financial assistance to any eligible tri-state area resident dealing with the costs associated with cancer treatment or with other individualized needs due to cancer care.

- Mileage reimbursement is available at \$0.45 per mile from home to a treatment center based on mapquest.
- Lodging reimbursement is available for up to \$75.00 per night, with receipt required.
- Meal reimbursement is also available, with receipts required, for up to \$7.00 per person for breakfast, \$10.00 per person for lunch and \$15.00 per person for dinner.
- Other assistance may be available for costs of comfort medications or medical equipment or supplies not covered by insurance.


These expenses add undue stress into an already stressful time. The Avery Foundation was developed to relieve you of some of this financial distress and allow you to focus your energy on the battle at hand.
